

An experienced Health, Safety and Environmental management practitioner with over 30 years' operational experience covering engineering and manufacturing industries, Mining and Construction, Smelting, Warehouses, Logistics/Transport, Offices, Commercial and Retail environments with a proven track record of implementing all aspects of safety management systems. Of the over thirty years of health and safety management experience, 13 years were spent undertaking in-house health and safety management within a blue-chip multinational mining company in Southern Africa (1990 -2003). In this role, experience was gained in all aspects of health and safety management, which included mineshafts lifting equipment. Examples amongst others being health and safety management systems development and reviewing; health and safety inspections and auditing; health and safety training and instructions. Projects health and requirements development safety implementation, one example being the now world renown Mimosa Platinum Mine in which I was the lead health and safety advisor from ground to planning to construction phase to commissioning. Management implementation health and safety; accident and incident investigations; assisting core business managers in risk assessments and safe method statements development until 2003 when I migrated to the UK. Before then I had worked in various capacity and levels as an Environmental Health Officer rising to a departmental Director (1979-1989).

After working in the housing sector as a Housing Officer/Health, and Safety Advisor in the UK (2004-2007), joined Peninsula in 2007 as a Health and Safety Consultant where I am currently a Principal Health and Safety Consultant. In this role, apart from assisting in the development of new Health and Safety Consultants, I remain a lead consultant in direct health and safety consultancy to clients, with special focus on construction. Amongst the

numerous activities involved in the role, examples of my work include:
